### **Section 23 of the Land Drainage Act 1991**

- the erection or alteration of any mill dam, weir or other like obstruction to the flow of any watercourse
- the erection or alteration of any culvert that would be likely to affect the flow of any watercourse

**Note:** Consent under the above legislation is required irrespective of whether the works are permanent or temporary.

### **Contraventions**

The Board can under Section 24 of the Land Drainage Act 1991 serve a legal notice requiring the person to abate the nuisance within a specified time. Failure to abide by such a notice can result in the Board carrying out the necessary remedial work and seeking to recover costs.

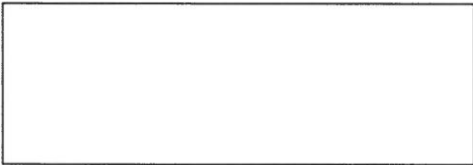
